#### 1. Definition

"3rd Level Grant Scheme" means that Finglas Credit Union Ltd will be offering up to **€1 ,000 for five** members for one year in 3rd Level Grant based on certain criteria from Finglas Credit Union Ltd. The 3rd Level Grants are exclusive to Finglas Credit Union Ltd members to allow them to attend their chosen full-time college or training course. Applications are invited from anyone who is currently attending or commencing training or educational courses.

#### 2. Eligibility

All eligible members who are over 16 years of age can apply to participate in the credit union 3rd Level Grant Scheme by completing the 3rd Level Grant Application Form.

#### 3. 3rd Level Grant Scheme Rules (terms & conditions): -

- All applicants must have been a member of Finglas Credit Union Ltd before 5<sup>th</sup> Sept 2026.
- The credit union will accept applications for full time courses only.
- The applicants account must be in good order and the account must not be in arrears.
- The course duration must be at least one year.
- Applicants must be residing in the Republic of Ireland.
- The successful applicant(s) will receive the 3rd Level Grant on the condition that they have been accepted on a training/third level course(s) and proof of acceptance will be required.
- All applicants are required to provide a personal statement in support of their application.
- Successful applicants will receive a 3rd Level Grant for one year.
- 3rd Level Grant holders may apply for subsequent schemes.
- If selected, the winning student must be available for promotional purposes for Finglas Credit Union Ltd.
- No cash payments will be made. The 3rd Level Grant will be in the form of payment for services such as fees, accommodation, books etc. Alternatively, receipts will be required for proof of purchase and payments will be issued.
- The decision of Finglas Credit Union Ltd. Board of Directors is final.
- Closing date for receipt of all applications is on or before 1.00pm on Saturday the 19<sup>th</sup> September 2026.

#### 4. Undertaking

In participating in the Credit Union 3rd Level Grant Scheme, the member agrees to make themselves aware of and abide by the 3rd Level Grant Scheme Terms and Conditions.

#### 5. Interpretation

These Terms & Conditions constitute the salient terms applicable to the provision of the 3rd Level Grant Scheme by the credit union.

#### 6. Identification

To ensure compliance with the Criminal Justice Act 2010 the member will be required to produce to the credit union satisfactory evidence of identity and current permanent address.

7. The credit union reserves the right to vary these terms and conditions if there is any relevant material change in the prevailing legal, tax or regulatory conditions or to enhance the security of the services provided by the credit union. The credit union reserves the right at all times to introduce new conditions or vary or amend existing conditions by giving at least fourteen days' notice thereof to the members, by whatever means deemed appropriate by the credit union which could include a notice displayed in the credit union offices.
